AND

LIONS CLUB OF DHEMAJI (322 D), the International Association of Lions Club, CLUB NO. 5362-078521 an International NGO, hereafter known as **LCOD** serving for to improve health and well being, strengthen community and support those in need for humanitarian services for maintain peace and international understanding, having its address at Dhemaji, Assam- 787057 herein after referred to as the 2nd. party of the other Part,

desiring to cooperate in the community services and protecting environment in the locality. PURSUANT to the prevailing laws and regulations, policies and procedures of both the institutions have reached the following understanding:

ARTICLE 1

OBJECTIVE OF THE UNDERSTANDING

The objectives of this Memorandum of Understanding (MoU) are-

- To improve health and well being of the people.
- To strengthen communities through social service and awareness.
- To support those in need through humanitarian services.
- To encourage peace and understanding for unity and integrity.

ARTICLE 2

SCOPE OF THE UNDERSTANDING

The parties agree to cooperate on the following points:

- Conducting awareness programmes on social issues..
- Conducting awareness programmes on environmental issues and green initiatives in the locality.

ARTICLE 3

LOCATIONS OF ACTIVITIES

- The Parties agree to implement the activities stated in Article 2 at MC, LCOD and Locality.
- Any changes of the location of the programs shall be mutually agreed upon by both the Parties.



**ARTICLE 4
FINANCIAL ARRANGEMENT**

- Any cooperation under this MoU is subject to the availability of funds, funding sources and approval by relevant authorities.
- Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

**ARTICLE 5
SETTLEMENT OF DISPUTE**

Any dispute concerning the interpretation and/ or application of this MoU shall be settled amicably through consultation or negotiation between both the Parties.

**ARTICLE 6
AMENDMENT**

- This MoU may be amended or revised at any time by mutual written consent of both the Parties.
- Such amendment or revision shall come into force on the date as may be determined by both the Parties.

**ARTICLE 7
ENTRY INTO FORCE, DURATION AND TERMINATION**

- This MoU shall enter into force on the date of signing.
- This MoU shall remain in force for a period of five years and may be extended by mutual written consent of both the Parties.
- Either Party may terminate this MoU at any time given prior written notification to the other Party on its intention to terminate this MoU.
- The termination of this MoU shall not affect the completion of any projects and programs in progress.
