desiring to cooperate in training and education in Yoga among the students and teachers as well as people of the locality for the greater interest of the growth of two institutions. PURSUANT to the prevailing laws and regulations, policies and procedures of both the institutions have reached the following understanding:

### ARTICLE 1

#### OBJECTIVE OF THE UNDERSTANDING

The objective of this Memorandum of Understanding (MoU) is to cooperate in conducting programmes on Yoga and Physical fitness in areas of mutual interest.

### ARTICLE 2

#### SCOPE OF THE UNDERSTANDING

The parties agree to cooperate on the following points:

- Yoga Training programmes among the students and teachers of MC.
- Conducting Awareness and Physical Fitness programmes in the locality.
- Skill- based courses that are mutually agreed upon by both the Parties.

### ARTICLE 3

#### LOCATIONS OF ACTIVITIES

- The Parties agree to implement the activities stated in Article 2 at MC, AYTC and Locality.
- Any changes of the location of the programs shall be mutually agreed upon by both the Parties.

### ARTICLE 4

#### FINANCIAL ARRANGEMENT

- Any cooperation under this MoU is subject to the availability of funds, funding sources and approval by relevant authorities.
- Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

### ARTICLE 5

#### SATTLEMENT OF DISPUTE

Any dispute concerning the interpretation and/ or application of this MoU shall be settled amicably through consultation or negotiation between both the Parties.

AMENDMENT**


- This MoU may be amended or revised at any time by mutual written consent of both the Parties.

ENTRY INTO FORCE, DURATION AND TERMINATION**


- This MoU shall enter into force on the date of signing.

- The termination of this MoU shall not affect the completion of any projects and programs in progress.


