MEMORANDUM OF UNDERSTANDING (MOU)

(SECOND PARTY)**

Acknowledging that, **Department of Assamese, Moridhal College**, hereafter known as **DAMC**, one of the departments of a premiere co-educational institution of higher education in Assam affiliated to Dibrugarh University, Dibrugarh, Assam herein after referred to as the **1st party of One Part**,

AND

Department of Assamese, Purbanchal College, Silapathar hereafter known as **DAPCS**, one of the departments of a premiere co-educational institution of higher education in Assam affiliated to Dibrugarh University, Dibrugarh, Assam, PIN- 787059 hereinafter referred to as the **2nd party of the other Part**,

Desiring to cooperate in academic and extra- curricular activities between students and teachers of the two institutions. PURSUANT to the prevailing laws and regulations, policies and procedures of both the institutions have reached the following understanding:

ARTICLE 1 OBJECTIVE OF THE UNDERSTANDING

The objective of this Memorandum of Understanding (MoU) is to cooperate in educational endeavours in areas of mutual interest.

ARTICLE 2 SCOPE OF THE UNDERSTANDING

The parties agree to cooperate on the following points:

- Exchange of best practices
- Faculty and students exchanges on academic and extra- curricular activities
- Skill- based courses that are mutually agreed upon by both the Parties.

ARTICLE 3 LOCATIONS OF ACTIVITIES

- The Parties agree to implement the activities stated in Article 2 at **DAMC** and **DAPCS**.
- Any change of the location of the programs shall be mutually agreed upon by both the Parties.

**ARTICLE 4
FINANCIAL ARRANGEMENT**

- Any cooperation under this MoU is subject to the availability of funds, funding sources and approval by relevant authorities.
- Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

**ARTICLE 5
SATTELEMENT OF DISPUTE**

Any dispute concerning the interpretation and/ or application of this MoU shall be settled amicably through consultation or negotiation between both the Parties.

**ARTICLE 6
AMENDMENT**

- This MoU may be amended or revised at any time by mutual written consent of both the Parties.
- Such amendment or revision shall come into force on the date as may be determined by both the Parties.

**ARTICLE 7
ENTRY INTO FORCE, DURATION AND TERMINATION**

- This MoU shall enter into force on the date of signing.
- This MoU shall remain in force for a period of five years and may be extended by mutual written consent of both the Parties.
- Either Party may terminate this MoU at any time given prior written notification to the other Party on its intention to terminate this MoU.
- The termination of this MoU shall not affect the completion of any projects and programs in progress.
